## **NEWS UPDATE**

August 16<sup>th</sup>, 2022

**Miami-Dade Police:** A Miami-Dade Police Officer was shot last night. Please keep the Miami-Dade Police Department, the involved officer, and their family in your thoughts and prayers.

**I.U.P.A.** and Command Meeting: The I.U.P.A. Local 6020, met with Sheriff Tony and members of his command staff on Thursday, August 11. Both sides expressed a desire to work together on a variety of topics to include approaching the Broward County Commission as a unified group when requesting additional money for a raise rather than on a divided front at impasse and a united lobbying effort to have the Florida Retirement System returned to just requiring first responders to work 25 years of service with a cost of living adjustment.

Florida Retirement System Proposed Legislative Update: The I.U.P.A. Local 6020, our parent union- the International Union of Police Associations, and the International Association of Fire Fighters (IAFF) have united our efforts to have the Florida Retirement System returned to just requiring first responders work 25 years of credible service to receive their pension with a cost of living adjustment. The I.U.P.A. Local 6020 has been in contact with multiple legislators and will keep the membership updated as this progresses. Following the meeting with Sheriff Tony and command staff, the I.U.P.A. Local 6020 will also be partnering with BSO's Government Affairs Department who can assist in advocating for this change. **Deputy Relief Fund:** The I.U.P.A. Local 6020 has a Deputy Relief Fund established to assist members who have a severe financial hardship. Local 6020 represents the member. The Deputy Relief Fund is funded by voluntary contributions. The more people who contribute to the fund the stronger the fund is. The I.U.P.A. **Legislative Efforts:** The parent union, the International Union of Police Associations, is also advocating for legislation beneficial to law enforcement. Below are some recent letters drafted by International President Cabral to elected officials across the country.

\*The Social Security Fairness Bill repeals provisions that reduce Social Security benefits for individuals who receive other benefits, such as a pension from a state or local government. President Cabral has written to United States Congress Members Kevin McCarthy and Nancy Pelosi urging them allow the bill to be brought before Congress.

\*Senate Resolution 732 states the Senate will recognize there is an ongoing and growing crisis at the southern border of the United States, commends Border Patrol agents who were deployed to the southern border, and that the Department of Homeland Security should commend rather than punish Border Patrol Agents who responded to the crisis. International President Cabral has written to Senator Ted Cruz commending him for introducing the resolution.

<u>The Heroes Lesley Zerebny and Gil Vega First Responders Survivors Support Act</u> increases survivor benefits for the Public Safety Office Benefits Program. International President Cabral has submitted letters to Congressman's Jim Jordan and Jerrold Nadler pass the proposed act.

The <u>Invest to Protect Act</u> provides money to departments with 200 offices or less. Invest to Protect funds may be used on mental health resources for first responders and additional training.
