Critical Incidents and Representation:

The I.U.P.A. Local 6020 provides its members with access to a Legal Defense Fund with approximately \$59,000,000 in reserves, with no caps on benefits. The Legal Defense Fund provides members full legal coverage for criminal and civil defense for acts committed within the scope of duty. If a member is involved in a critical incident, like a deputy-involved shooting, the I.U.P.A. will provide an attorney on-scene to represent the member.

If a member is involved in a critical incident, please contact one of the I.U.P.A. Local 6020 Executive Committee members, 24 hours, 7 days a week. One of the Committee members will respond to the scene along with the Legal Defense Fund on-call attorney.

We will ensure that our members get the best possible representation throughout the duration of their case.

As a reminder, the I.U.P.A. Local 6020 also provides its members full attorney representation for all internal disciplinary matters.

If a member is the subject of an Internal Affairs investigation, that member will normally be represented by Attorney Mike Finesilver, and *not* by a non-attorney Representative. For cases that are only administrative as a violation of policy, the I.U.P.A. Local 6020 provides our in-house Attorney, Mike Finesilver, to our members. Attorney Finesilver has over 38 years of experience practicing law. He is very familiar with the Broward Sheriff's Office personnel, as well as the policies and procedures of BSO, and has been defending law enforcement officers for decades with an excellent track record.
